PRODUCE PROCUREMENT PROGRAM: AFTER THE HARVEST (ATH) WORKS WITH LARGE COMMERCIAL PRODUCERS (FARMERS, GROWERS), PRODUCE PACKERS, RETAILERS, ETC., TO ACQUIRE PRODUCE DONATIONS IN LARGE VOLUMES, AND HAVE THEM TRANSPORTED TO FOOD BANKS IN MISSOURI AND KANSAS, PARTICULARLY TO HARVESTERS - THE COMMUNITY FOOD NETWORK, IN KANSAS CITY.
